## RELEASE OF LIABILITY - READ BEFORE SIGNING

2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation: and
3. I will agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of an officer, agent, or employee of JVO immediately: and

I, do myself and on behalf of my heirs, assigns, personal representatives and the next of kin, HEREBY RELEASE, INDEMNIFY, AND HOLD HARMLESS JVO, their officers, officials, agents, and/or employees, and other participants, sponsoring agencies, sponsors, advertisers, and owners and lessors of premises used for the activity (Releasees), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associated with my presence or participation WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE, to the fullest extent permitted by law; and
5. I acknowledge that JVO will supply me with a Personal Flotation Device (P.F.D.) and that it is my responsibility to use it properly; and
6. I agree that any photographs, video or other medium made of me during my time spent on the premises, during transport or at any other time by JVO or a party of JVO are the sole properties of JVO and can be used in advertising, promotion or any way JVO sees fit: and
7. I agree that if I do file suit against JVO, it will be filed in Charlevoix County, Michigan, under Michigan law.
